



2020 Membership Categories explained

The following outlines playing restrictions applicable to membership categories. **Members age for the season is determined by their age on **January 1st** of the current year.

UNLIMITED GOLF – 18 HOLES

Gold Shareholder – Adults aged forty-five (45) and over, unrestricted golf, 7-days a week, with a share in their name, or spouse’s name. This category includes a discount on one (1) service (listed below).

Gold Non-Shareholder – Adults aged forty-five (45) and over, unrestricted golf, 7-days a week, without a share in their name, or spouse’s name. This category includes a discount on one (1) service (listed below).

Weekday Shareholder – Adults aged forty-five (45) and over, Monday to Friday including holidays, with a share in their name, or spouse’s name. Green fees apply to any weekend play, except the Club Championship. This category includes a discount on one (1) service (listed below).

Weekday Non-Shareholder – Adults aged forty-five (45) and over, Monday to Friday including holidays, without a share in their name, or spouse’s name. Green fees apply to any weekend play, except the Club Championship. This category includes a discount on one (1) service (listed below).

Family Shareholder – An adult member, their spouse and dependent children who meet the qualifications for a junior membership, or are attending a secondary education facility full time (up to twenty-four (24) years of age), unrestricted golf, with a share in their name, or their spouse’s name. This category includes a discount on two (2) services (listed below).

Family Non-Shareholder – An adult member, their spouse and dependent children who meet the qualifications for a junior membership, or are attending a secondary education facility full time (up to twenty-four (24) years of age), unrestricted golf, without a share. This category includes a discount on two (2) services (listed below).

Services available with membership categories above: 15% off a power cart package; individual, couple or two-person package, or 50% off range membership, or 50% off club storage. Note: A second/third service option (multi-service) discount is offered on the range membership and club storage of 10% on each additional service.

UNLIMITED GOLF – 9 HOLES

Gold Shareholder and Non-Shareholder – Unrestricted 9-holes rounds of golf, after 1pm 7-days a week, including member events and leagues, with or without a share in their name, or their spouse's name. Green fees apply to any additional play, except the Club Championship which is included.

LIFESTYLE MEMBERSHIPS

18 Holes

Silver 25 Shareholder – Unrestricted golf including member events and leagues, up to a maximum of twenty-five (25) rounds, with a share in their name, or their spouse's name. Green fees apply to any additional play, except the Club Championship which is included.

Silver 25 Non-Shareholder – Unrestricted golf including member events and leagues, up to a maximum of twenty-five (25) rounds, without a share in their name, or their spouse's name. Green fees apply to any additional play, except the Club Championship which is included.

Silver 15 Shareholder and Non-Shareholder – Unrestricted golf including member events and leagues, up to a maximum of fifteen (15) rounds, with or without a share in their name, or their spouse's name. Green fees apply to any additional play, except the Club Championship which is included.

9 Holes

Silver 25 Shareholder and Non-Shareholder – Unrestricted golf including member events and leagues, up to a maximum of twenty-five (25), 9-hole rounds, with or without a share in their name, or their spouse's name. Green fees apply to any additional play, except the Club Championship which is included.

Silver 15 Shareholder and Non-Shareholder – Unrestricted golf including member events and leagues, up to a maximum of fifteen (15), 9-hole rounds, with or without a share in their name, or their spouse's name. Green fees apply to any additional play, except the Club Championship which is included.

UNLIMITED GOLF – INTERMEDIATE

Age 19 to 24 Shareholder and Non-Shareholder – Must have attained the age of nineteen (19) years but not yet twenty-five (25). Unrestricted golf, with or without a share in their name, or spouse's name.

Age 25 to 34 Shareholder – Must have attained the age of twenty-five (25) years but not yet thirty-five (35). Unrestricted golf, with a share in their name, or spouse's name.

Age 25 to 34 Non-Shareholder – Must have attained the age of twenty-five (25) years but not yet thirty-five (35). Unrestricted golf, without a share in their name, or spouse's name.

Age 35 to 44 Shareholder – Must have attained the age of thirty-five (35) years but not yet forty-five (45). Unrestricted golf, with a share in their name, or spouse's name.

Age 35 to 44 Non-Shareholder – Must have attained the age of thirty-five (35) years but not yet forty-five (45). Unrestricted golf, without a share in their name, or spouse's name.

Weekend after 12pm – Unlimited, restricted golf membership including member events, after 12pm on Saturdays and Sundays. Green fees apply to any additional play, except the Club Championship which is included.

Out of Town – Must reside at least 75km from Hampton Golf Club. Proof is needed. Unlimited golf membership including member events and leagues. The Club Championship is included. The Golf Committee may need to approve the membership.

Student – Must be in full-time education. Unrestricted golf, with or without a share in their name, or spouse's name.

JUNIORS

Junior 8 to 10 - Must have attained the age of eight (8) years but not yet eleven (11). Unrestricted golf, outside of the leagues, and after 12pm at weekends.

Junior 11 to 13 - Must have attained the age of eleven (11) years but not yet fourteen (14). Unrestricted golf, outside of the leagues, and after 12pm at weekends.

Age 14 to 18 - Must have attained the age of fourteen (14) years but not yet nineteen (19). Unrestricted golf, outside of the leagues, and after 12pm at weekends.

All Junior memberships are subject to a \$25 group lesson fee.

Other information

- **Food & Beverage** credit is included in most* memberships. This can be used in the restaurant and beverage cart. You can purchase more credit or redeem for a gift card.

Gold, Weekday & Intermediate = \$100.00 + 10% bonus = \$110.00 (Included)

Family = \$150.00 + 10% bonus = \$165.00 (included)

Lifestyle, 9-hole Gold, Weekend after 12pm & Out of Town = \$50.00 + 10% bonus = \$55.00 (Included).

Junior and Students do not have Food & Beverage credit included.

- **Cart Trail Fee** – Fee for using own personal cart (grandfathered) on the premises of Hampton Golf Club.

- **Couples** – Legally married or considered to be a couple under the rules established by the Board of Directors.
- **Juniors (Novice, Bantam & Juvenile)** – Can play anytime outside of league play and on weekends & holidays play is permitted after 12pm.
All Junior memberships are subject to a \$25 group lesson fee. 5-week junior program. June to July.
- All membership categories have the ability to purchase additional Club Services.
- **Membership Installments** are by direct-debit/EFT. Billed on the 1st of every month. March through November. 9-months.
- Children under the age of eight (8), being children or grandchildren of members may play **after 5:00pm** accompanied by an adult at no charge. Access to practice facility on off peak times accompanied by an adult at no charge.
- **Golf Canada** memberships are included for all Unlimited Golf Memberships. Limited round/restricted members may purchase a Golf Canada Membership at a discounted price.
